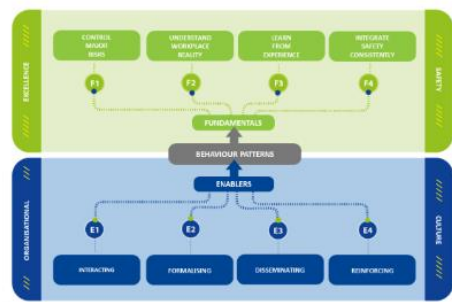

Phase 1: Pilot phase - Information gathering
