3. Use of this document

Member States may decide, following the provisions 7.4.3.2 and 7.4.3.2 of [1] to exclude special vehicles from the obligation to equip them with ETCS, RMR or ATO on a specific area of use if the operation of these vehicles does not prevent the Class B decommissioning or passenger trains reserved to a strictly local use or shunters as defined in Commission Regulation (EU) 1302/2014 that operate exclusively on a part of the national network where no ETCS exists and until it is equipped.

The Agency in coordination with the National Safety Authorities, has decided to collect these exclusions and make them available in this technical document to facilitate the consultation of these exclusions until RINF is prepared to support this notification.

4. Content of the document

The table contains information about the decision of different Member States to apply the above-mentioned provisions. Crosses 'X' represent a notified exclusion. Blanks define no notified exclusion from the Member State. The table only reflects received notifications, Member States not listed shall be considered as not applying the provisions of 7.4.3.2 and/or 7.4.3.3 of [1].
