2021 at a glance

Rail was omnipresent in 2021, the European Year of Rail. Throughout the year, the Agency has been successful in achieving its milestones and delivering on its core mission. ERA timely delivered on its Authority tasks, noticing a significant increase in the volume of applications. When it comes to National Safety Authorities, the Agency completed its first three-year monitoring cycle. ERA has also continued the monitoring of Notified Bodies and has launched the revision of the dedicated Assessment Scheme. In addition, the Agency successfully launched and concluded the Safety Climate Survey, which gathered over 46,500 responses. Furthermore, the consultation on the 2022 TSI revision package on Telematics applications for freight and for passengers took place. Through its mission and actions, the Agency continued to contribute to the EC Political guidelines: a European Green Deal, an economy that works for people, a Europe fit for the digital age, and a stronger Europe in the world.



ERA's strategic role was obvious in 2021, the European Year of Rail, that shone a light on all our activities, contributing to making rail the transport option of choice for both passengers and freight. We will continue to work tirelessly to move Europe towards a sustainable and safe transport system without frontiers in which rail plays the key role.
