DECISION n° 182

of the Management Board of the European Union Agency for Railways on the adoption by analogy of Commission Decision (C2018-4048) of 29.6.2018 on outside activities and assignments and on occupational activities after leaving the Service

THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR RAILWAYS,

Having regard to the Regulation (EU) 2016/796 of the European Parliament and of the Council of 11 May 2016 on the European Union Agency for Railways and repealing Regulation (EC) No 881/2004¹ (hereinafter called “the Regulation”);

Having regard to the Staff Regulations of Officials of the European Union and the Conditions of Employment of Other Servants of the European Union, laid down by Council Regulation (EEC, Euratom, ECSC) No. 259/68², and in particular Articles 11, 12 and 13 and 110 of the Staff Regulations;

After consulting the Agency Staff Committee,

Whereas:

- (1) The Commission formally notified the Agency it adopted Decision (C2018-4048) of 29.6.2018 on outside activities and assignments and on occupational activities after leaving the Service;
- (2) The Agency was also notified through the Standing Working Party that the Commission Decision had to be applied by analogy as no model decision will be developed for agencies (without prejudice to the fact that an agency can opt out and start bilateral discussions order to have a specific decision);
- (3) The application by analogy of Commission Decision (2013) 9037 on outside activities and assignments adopted by Decision N° 730 of the European Railway Agency on the adoption of implementing rules to the Staff Regulations should be repealed;

HAS DECIDED AS FOLLOWS:

Article 1

Commission Decision (C2018-4048) of 29.6.2018 on outside activities and assignments and on occupational activities after leaving the Service shall apply by analogy at the Agency.

Article 2

The application of Commission Decision (2013) 9037 on outside activities and assignments adopted by Decision of N° 730-2013 of the European Railway Agency on the adoption of implementing rules to the Staff Regulation is hereby repealed.

Article 3

This Decision shall apply on the day following that of its adoption. It shall be published on the Agency's website.
