DECISION n°97

of the Administrative Board of the European Railway Agency adopting an amending budget 2014

THE ADMINISTRATIVE BOARD OF THE EUROPEAN RAILWAY AGENCY,

Having regard to Regulation (EC) No 881/2004 of the European Parliament and of the Council establishing a European Railway Agency¹ (hereinafter referred to as "the Agency"), and in particular article 38(8) thereof,

Having regard to the Agency's Financial Regulation adopted on 31 December 2013 and in particular article 34 thereof,

Whereas:

The figures in the revenues of the budget 2014 adopted by the Administrative Board on the 26 November 2013 are not aligned with the figures in the European Commission budget for the Agency.

HAS DECIDED AS FOLLOWS:

Article 1

The Agency's Budget 2014 shall be amended as follows:

The total budget is increased by ≤ 20600 and reaches ≤ 25715600 (instead of ≤ 25695000) with a different distribution on the revenue side.

Recourse to a negative reserve frequently helps to resolve conflicts between the various parties in the budget debate.
