## WORK EXPERIENCE (from Sept 2019)

### Legal Officer and Security Inspector

EFTA Surveillance Authority

The EFTA Surveillance Authority (ESA) monitors the implementation of EEA legislation in the EEA EFTA States (Norway, Iceland and Liechtenstein). The tasks of ESA to a large extent mirrors the monitoring tasks of the European Commission. In my portfolio, I work with the railway acquis mainly, but also partly with aviation and road transport acquis. Amongst several tasks, I investigate national legislation and practice concerning that acquis. This task includes e.g. assessing complaints, carrying out conformity assessments, opening own initiative cases on incorrect implementation, assessing reports, meeting with the national governments and competent authorities.

Additionally, I work as a security inspector in the fields of aviation and maritime security.

## WORK EXPERIENCE (from Jan 2017 to Aug 2019)

### The Norwegian Ministry of Transport and Communications

Legal Advisor/EEA-coordinator

I was the EEA coordinator in the Aviation Section with overall responsibility for following up and participating in ongoing regulatory processes in the EU. The task entailed, among other things, attending meetings in the EU, drafting laws and regulations to ensure implementation of EEA rules. A key task was to ensure that Norway fulfilled its obligations under the EEA Agreement. On a regular basis, I represented the Norwegian Ministry of Transport in the EASA Committee and the EFTA Working Group on Transport.

I was also a case handler, and some of my areas of responsibilities were general aviation, air safety regulations, Brexit contingency regulations, air service agreements and the Norwegian Freedom of Information Act.

## WORK EXPERIENCE (from Jan 2014 to Dec 2016)

### NAV Klageinstans (The Appeal Body of Norwegian Labour and Welfare Administration)

Legal Advisor/Coordinator

My main task was to examine complaints. The topics varied from membership of the National

Insurance Scheme, including membership for citizens of EEA states, to disease-based benefits. I would also prepare cases for court proceedings. Furthermore, I was appointed as a coordinator just after six months, and was given the responsibility of mapping how the laws and regulations were practiced in the Norwegian Labour and Welfare Administration departments across Norway. Through analysing data from the departments I wrote quality reports to the administration. Based on the results we would write circulars and guidelines on how to interpret the laws and regulations. I would also answer questions on interpretation both on telephone and online. I was also asked to participate in the Ministry of Labour and Social Affairs' work on revising parts of the National Insurance Act.
