Informative lists of border stations in accordance with Article 10(8) of Directive (EU) 2016/798

Before the submission of its application for a single safety certificate, the railway undertaking is always invited to liaise with the relevant national safety authority (NSA) to confirm whether:

- the station or stations in its territory are border stations pursuant to Article 10(8) of Directive (EU) 2016/798,
- existing cross-border agreement(s) or case-by-case arrangements (i.e. ad hoc consultation) apply on the border station(s) it intends to operate,
- relevant notified national rules and obligations pertaining to the relevant cross-border agreements apply.

It is assumed that in the case where:

- Cross-border agreements are under development between two Member States and/or international agreements (Int) on cross-border traffic exist, there might be ad hoc consultation between the safety certification body and the NSA of the Member State where the border station is located;
- The border station or section is not included in one of the lists below, the applicant should in principle extend the area of operation to the relevant Member State where that station or section is located.

The following lists are published for information only and have no legal effect. Although they are developed based on information communicated by the different NSAs to ERA, they may still contain errors or omissions. [Please consult the concerned NSAs and their respective application guides.](#)
