DECISION n° 330

of the Management Board of the European Union Agency for Railways amending the Single Programming Document 2023 (amendment n°3)

THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR RAILWAYS,

Having regard to Regulation (EU) N° 2016/796 of the European Parliament and the Council of 11 May 2016 on the European Union Agency for Railways (hereinafter referred to as "the Agency") and repealing Regulation (EC) No 881/2004 (hereinafter called "the Regulation"), and in particular Article 51(1)(b) and 52(4) thereof,

Having regard to Decision n° 310 of the Management Board adopting the Single Programming Document 2023 and to any subsequent amendments adopted,

Having regard to Decision n° 206 of the Management Board adopting the new ERA financial regulation,

Having regard to Decision n° 317 of the Management Board on delegating powers to the Executive Director to adopt non-substantial amendments to the Single Programming Document and repealing Decision n° 289,

HAS DECIDED AS FOLLOWS:

Article 1

The text in the Annex to MB Decision n° 310 of the Management Board adopting the Single Programming Document 2023, as amended by MB Decisions n° 325 and n° 328, is further amended with the substantial changes listed in the Annex to this decision.

Article 2

This decision shall enter into force on the day following that of its adoption. It will be published on the Agency's website.

 - 3.1.1 Satellite for rail conference in Madrid

At the end of July 2023 the Agency identified an urgent need to organise a procurement for the Satellite for Rail conference to take place on 13 and 14 September. This event, which the Agency will co-organize with EURail and EUSPA, is outlined in the Communication Plan approved by the MB. Regrettably, the associated procurement was not included in the procurement plan annexed to the adopted SPD.

Article 72(1) of the ERA Financial Regulation specifies that there needs to be a financing decision before a budgetary commitment. Given the timing the need was identified and the absence of an MB meeting before the event's organisation, coupled with the insufficient time to successfully complete a written procedure, the Agency, faced with this force majeure, was not in the possibility to amend the SPD including amended procurement plan prior to the event.

The Agency has considered and assessed all possible solutions and has concluded that an ex-post amendment of the SPD, including amended procurement plan, was the most viable option. Withdrawing from the organisation of the event would have posed significant reputational risks for the Agency.

As a medium to long term follow-up solution, the Agency shall make sure to have a timely planning of the events to be organised, including a 1-to-1 mirroring in the procurement plan.

By its activities in 2023, the ERA Academy has been continuously contributing to the European Year of Skills. At the Safety Days Conference in September 2023 learning is a major topic. In addition, it is developing its e-learning platform, organising trainings, and making the utmost out of the available resources by e.g., organising an additional introductory visit for NSA staff to its premises, performing a training needs analysis and continuing its active participation in the Staffer initiative.

However, due to the pressure on internal resources, the Agency has not had the opportunity to organise this event in 2023. It will be re-considered for future years.

The event was originally planned to use a direct contract, with a market ceiling of EUR 25,000. However, in June 2023 it was identified that due to a newly discovered clause in the framework contract concerning its term of validity until the end of 2023, it became apparent that the conference will have to be organised via SCIC framework contract and not, as originally planned, via direct contract. As a consequence, the market ceiling had to be raised from EUR 25.000 to EUR 35.000 in order to cover the entire range of services needed.
