DECISION n° 342

of the Management Board of the European Union Agency for Railways amending the Single Programming Document 2024-2026 (#1)

THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR RAILWAYS,

Having regard to Regulation (EU) N $^{\circ}$ 2016/796 of the European Parliament and the Council of 11 May 2016 on the European Union Agency for Railways (hereinafter referred to as "the Agency") and repealing Regulation (EC) No 881/2004 (hereinafter called "the Regulation"), and in particular Article 51§1 (b) and 52§4 thereof,

Having regard to Decision n° 336 of the Management Board of the European Union Agency for Railways adopting the Single Programming Document 2024-2026,

Having regard to Decision n°206 of the Management Board adopting the new ERA Financial Regulation,

HAS DECIDED AS FOLLOWS:

Article 1

The text in the Annex to the MB decision 336 of the Management Board adopting the Single Programming Document 2024-2026 is amended with the substantial changes listed in the Annex to this decision.

Article 2

This decision shall enter into force on the day following that of its adoption. It will be published on the Agency's website.

1. Substantial amendments of the SPD 2024-2026 procurement plan

1.1. New Procurement procedures

1.1.1 Provision of catering services

Description	Market ceiling
Provision of catering services	95,000€

The purpose of the new procurement procedure is to find a company providing catering to the Agency, through the delivery of beverages, sandwiches and salads for meetings organised in its headquarters in Valenciennes.

On 15 November 2023, the Agency current contractor (caterer "Classe Croute") informed that it will cease its activities by the end of that month. This was unexpected, as there had been no previous indication that the situation might arise. The reason invoked was the difficulties linked to the current economical context. As several events needing catering are foreseen in 2024, the Agency needs to urgently organise a new call for tenders.

1.1.2. FWC for event management services

Description	Market ceiling
Launch a tender for a FWC to contract services for event management organised by the Agency over 4 years (mid-2024/ mid-2028)	2,000,000€

The FWC "SCIC/C1/2018/FWC/02 Event management services" supporting the current Communication and Dissemination Plan adopted by the ERA MB on 16.11.2023 (<u>Decision n° 333</u> – Multiannual Comms and dissemination plan 2024-2028) ended on 23 July 2023. However, it has been extended for six months and will end at the latest, on 23/01/2024. Specific contracts signed prior to the ending of the contract can be implemented for a period up to 9 months.

On 1st June 2023, SCIC notified ERA procurement that it was about to launch a new FWC call, but the new SCIC FWC will only cover events organised by the European Commission and the Executive Agencies. Therefore, ERA would not be in the position to use the new SCIC FWC.

Currently there is no other FWC for event management which can be used by ERA. Therefore, the Agency must launch a call for tender to establish its own FWC for event management services.

As this call will require several months preparation, it will be possible to use the new ERA FWC for event management from mid-2024 onwards.

To cover the ERA events from mid-2024 onwards, the tender must be launched early 2024, and to do so, the Procurement Plan must be preliminary amended, as the tender was planned to be launched within 2023.

The budgetary envelope to cover the ERA major events of the next 4 years, starting mid-2024, is estimated at 2 million FUR.

1.1.3. FWC for website management services

Description	Market ceiling
Launch a tender for a FWC to contract services for website management organised by the Agency over 4 years (mid-2024/ mid-2028)	150,000€

The FWC "OC_EFSA_COM_2019_01 LOT 2-01 Development of static and interactive information and storytelling products" which the Agency has used in the past years for website management services, expires on 22/06/2024.

EFSA confirmed that it does not intend to extent this FWC, nor launch a new interagency call. Therefore, the Agency must launch a call for tender to establish its own FWC for website management services.

As this call will require several months of preparation, the Agency intends to use the new ERA FWC for website management services from mid-2024 onwards.

To cover the website management from mid-2024 onwards, the tender must be launched early 2024, and to do so, the Procurement Plan must be preliminary amended.

The budgetary envelope to cover the ERA website management of the next 4 years, starting mid-2024, is estimated at 150,000€.

Rationale of the requested changes:

- Increasing the original market ceiling by 30,000€ (from 220,000€ to 250,000€) to keep up with the overall market indexation.
- As explained in the section 1.1.2., the Agency will use the SCIC Framework Contract, as this contract can be implemented up to 9 months after the expiration of the contract.

Rationale of the requested changes:

- The Parties (ERA, ERJU, DG-MOVE) acknowledge that the InnoTrans fair is the largest rail and transport technology fair worldwide, with more than 137,000 attendants from 3,000 companies and 56 countries in the 2022 edition. The fair presents a great opportunity to pass on EU policy messages to the rail sector, and the Parties have previously coordinated their presence at InnoTrans and harmonised programmes to promote EU activities.
- The Parties agreed that with a single EU transport stand, the impact of those messages will increase, and, therefore, commit to an integrated planning for InnoTrans 2024. The Parties will work collaboratively to ensure that the needs of each party are reflected and protected within the common project while all parties benefit from the advantages of a single stand presence.
- The Parties recognise that a single EU stand will result in a stronger presence and a common corporate image of the EU institutions towards the rail sector. The Parties will create a meeting space that will be strongly recognised in the framework of the fair's programming. There will be the possibility to set one common agenda, using speakers and resources from all involved EU institutions, thereby saving cost and time.
